Project #1: (ENDS)

• Electronic Nicotine Devices (ENDS) usage and the associated knowledge, perceptions and biomarker findings among California youth: a biopsychosocial evaluation of ENDS usage and addiction.

Project #2: (QI)

• Substance Use Screening QI Project: Current Screening Practices of Substance Use: A Retrospective chart review



Background/Purpose

ENDS Project:

- **Goal 1:** To investigate the baseline perceived addictiveness and factors contributing to the initiation and continuation of ENDS usage among youth
- **Goal 2:** To outline the development/evolution of psychological and biochemical nicotine dependence over time
- **Goal 3:** To qualitatively investigate the motivating factors leading to continued and the initiation of ENDS usage

QI Project:

- Goal 1: To outline screening practices regarding substance use
- **Goal 2:** Plan PDSA cycles to improve documented screening rates






Methods / Results

ENDS: Phase 1 analyses of addiction and addictiveness

• Project #1: Cross-sectional evaluation of perceptions of addiction, and addictiveness among California youth (N=764)



If you used the following products 2-3 x/day, what is the chance that you (0-100%)...








Methods / Results

QI Project: Retrospective chart review

- Phase 2: To outline the development of psychological and biochemical nicotine dependence over time
- Phase 3: To qualitatively investigate the motivating factors leading to continued and the initiation of ENDS usage

QI Project:

- PDSA #1: To assess impact of new screening form with imbedded CRAFFT 2.0
- PDSA #2: To assess impact of intake CRAFFT screening done via iPad versus paper questionnaire
